WI Motorcoach Association Legislative Report November 13, 2023

2023 WI Act 26: Enacted on August 5, 2023, this new law allows school board member to act as a volunteer school bus driver.

Previously, school board members could not hold other positions within the school district other than a volunteer coach or extracurricular activity supervisor to avoid any conflicts of interest.

This new law adds 'volunteer bus driver' to the list of other positions so long as:

- The person is authorized by the Department of Transportation to drive a school bus.
- The person holds a valid commercial driver license.
- The person does not receive compensation for serving as a volunteer bus driver.
- The person agrees to abstain from voting on any issue before the school board that directly concerns school bus drivers.

AB 274 and SB 271: Requires the Department of Workforce Development to establish a commercial driver training grant program that provides grants to persons or other entities that provide training leading to an individual receiving their CDL. The total amount authorized is \$250,000.

We have testified before both the Senate and Assembly committees on the legislation and are very optimistic it will pass and be enacted into law but know that more work and funding is needed for the program.

There is another bill similar to this, Assembly Bill 594 which would provide grants to technical colleges for hiring bonuses to instructors who teach CDL students, up to \$5,000. If the instructor remains at the school for at least five years, they will be eligible for another \$5,000 retention bonus. We are registered in support.

SB 313 and AB 313: This bill increases the penalties from \$30 - \$33 to \$300 - \$1,000 for failing to stop for a school bus that has stopped and displaying flashing red lights. The bill also requires DOT to assess three demerit points for motorists who violate the stop requirement. The bill passed out of the Senate Transportation Committee and is waiting floor scheduling.

SB 354: This bill requires the DOT to administer a verbal school bus safety examination that includes the hazards posed by other motor vehicles to school buses and passengers loading or unloading from school buses and of the laws that require motorists to stop when a school bus is displaying flashing lights.

The bill also specifies that knowledge tests driver's license applicants must include material testing the applicant's knowledge of the hazards, and that technical colleges and private driver schools must also provide similar instruction and information.

The bill is currently in the Senate Transportation Committee, but no further action has been taken.

Federal S.1944 – CERTS Tax Elimination: This legislation would eliminate the tax burden associated with the \$2 billion CERTS grant monies provided to motorcoach, school bus and passenger vessel industries. It is currently in the Senate Finance Committee, but no further action has been taken.
