# WI Motorcoach Association Legislative Report November 14, 2024

## 2024 NATIONAL AND STATE ELECTIONS

Donald Trump wins both the popular and electoral college vote, 312 in total which is considered a landslide.

Republicans regain control of the US Senate by a margin of 53-46 and it appears Arizona will go to the Democrats.

Republicans may hold the majority in the US House of Representatives but it's still unclear at this time. As of November 11, they have 214 seats and are only 4 seats away from holding the majority.

All Wisconsin House members retained their seats, so no change there. In the Green Bay area, Republican Tony Wied won the seat in an open district.

Republicans hold the majority in the State Legislature, but their majority was decreased slightly in both the Assembly and Senate.

The Republicans no longer have a super-majority in the State Senate, but still have an 18-15 majority. In the State Assembly, Republicans hold is now 54 seats and Democrats have 45, but a couple of those seats have been officially announced.

## LEGISLATURE OUT OF SESSION

The 2025-26 State Legislature is out of session and legislators will return to the duties during the first week of January, 2025. Republicans will hold the majority in both Houses, but the number of seats held primarily in the State Assembly will tighten up between the two parties.

## 2023 Wisconsin Act 154

The new law increases the penalty for failing to stop for a school bus as required to a forfeiture of not less than \$500 and not more than \$1,000. The law also requires the Department of Transportation to assess four demerit points against the driving record of a person who fails to stop for a school bus as required.

## 2023 Wisconsin Act 153

The new law requires the Department of Workforce Development (DWD) to establish a commercial driver training grant to persons and entities that provide CDL training. Grants may not exceed, for each person trained, 50% of the cost to train that person or \$3,000, whichever is less. The deadline for applications and sunset of the funding is July 1, 2025.

**SB 354 and AB 614** require the DOT to administer a verbal school bus safety examination that includes the hazards posed by other motor vehicles to school buses and passengers loading or unloading from school buses and of the laws that require motorists to stop when a school bus is displaying flashing lights.

The bill also specifies that knowledge tests driver's license applicants must include material testing the applicant's knowledge of the hazards, and that technical colleges and private driver schools must also provide similar instruction and information.

Both bills did not advance in the Legislature and thus, have expired.

## DOT SECRETARY THOMPSON DEPARTS

DOT Secretary Craig Thompson has left the agency for a position as vice chancellor at UW-Madison.

Deputy DOT Secretary Kristina Boardman has been appointed to take Thompson's place and will become the first woman to serve as secretary of the department. Boardman has 20 years of experience with the DOT and previously served as the administrator of the Division of Motor Vehicles. Before that, she spent a decade in the State Assembly as a legislative aide.
